Kelowna Chamber Marks 112th AGM with full slate of Directors and a new President

Kelowna - The Kelowna Chamber of Commerce hosted its annual general meeting on Tuesday March 13, 2018 at the Ramada Hotel and Conference Centre. A full slate of directors, including four fresh faces, was introduced to members following online voting.

Speaking about 2017-2018, outgoing President Tom Dyas acknowledged it was one of the busiest years on record for the Chamber, not only with the leadership transition that was initiated a year ago, but because of the significant number of government policies that came under the Chamber's microscope.

The Kelowna Chamber ramped up its role as the voice of business during the year, stepping its advocacy efforts with all levels of government. The Chamber took on the proposed federal corporate tax changes, the provincial increases in the minimum wage, and new taxes being introduced by the provincial government, as well as the ongoing issues related to the City's efforts to manage growth while keeping taxes in check. The Chamber also held its first membership Policy Forum in the fall and expanded the role of its Policy Advisory Committee.

In recapping the past year, Dyas also extended a thank you to the returning directors for continuing on the board for the coming year. "Board continuity is extremely important for any organization, and for a business organization with a volunteer board, is always a critical part of strategic planning and success."

The board executive remains relatively unchanged from 2017; though Carmen Sparg takes over as President from Tom Dyas who served two terms in that post. Dyas will remain on the Board as Past President.

"It is an honour to take over as President of the Chamber," stated Sparg, who added, "Following in Tom's footsteps won't be easy. He was very active on a number of files, championing the needs of our members and the business community wherever he could. I am excited to work with the new board which have diverse backgrounds, plenty of experience and some new blood that will help shape the Chamber's future growth."
