Kevin keeps coming out with outstanding ideas, creating remarkable partnerships, including with Food for Thought (2500 children a day in SD23 get breakfasts through Food for Thought and the Central Okanagan Food Bank) and always soberly reminds us that we're all educating the business leaders and workers of tomorrow – and tomorrow is always arriving, every day, ready or not.

Of course, as a Chamber, we are preparing for our annual AGM (in March) and that means an election for our volunteer Board of Directors.
