BC CHAMBER

The BC Chamber's grassroots policy-development process is second-to-none in British Columbia. Every year, its membership of businesses, Chambers of Commerce and Boards of Trade develops policies that reflect the on-the-ground needs of BC businesses. Through this process, the membership endorses approximately 40 new policies every year at its Annual General Meeting. The breadth and diversity of the policies reflect its broad-based membership; during any given year, it has policy recommendations for the majority, if not all, of BC's provincial government ministries. POLICY & ADVOCACY INFORMATION – BOARD CANDIDATES

KELOWNA CHAMBER POLICY ADVISORY COMMITTEE

Purpose: To provide leadership in identifying and taking action on local, provincial and federal issues of specific interest to members and key stakeholders of the Kelowna Chamber of Commerce and of concern to the business community at large.

Duties and Responsibilities:

- Oversee the strategic priorities as assigned to it by the Board. (Annual goals of the committee)
- Engage members to identify and prioritize local, provincial and federal issues.
- Review requests from members for support on advocacy issues or resolution requests. Report as needed and provide recommended action as appropriate.
- Prepare policy resolutions for approval by the board of directors.
 - Develop and implement local, provincial and federal advocacy plans.
 - Conduct research and meet with experts to seek out expert opinions on specific local, provincial or federal issues as appropriate.

THE CHAMBER POLICY YEAR AT A GLANCE

NOVEMBER

Hold member policy development session

DECEMBER

Review policy submission ideas. If new (not on books) proceed with research/writing. Share with Valley Alliance.

JANUARY-FEBRUARY

Research, draft policies; review by Policy Advisory Committee (PAC), VPA.

MARCH

Submit new policy drafts to BC Chamber Policy Review Committee (PRC). Finalize drafts for Canadian Chamber submission. Share drafts with other chambers to generate support & feedback.

APRIL

BC Chamber PRC gives feedback, generally requiring some re-drafting. Finalize drafts for Canadian Chamber.

MAY

Attend BC Chamber annual Policy Review Session; present, amend, defend, adopt. Submit policy drafts to CCC.

JUNE

BC Chamber Policy Manual published. Copies sent to provincial ministries. Regional BC consultations scheduled; Present to opposition critics. Federal policy review committee gives feedback on federal submitted policies.

POLICY & ADVOCACY INFORMATION – BOARD CANDIDATES

JULY-AUGUST

Ministerial sessions held, BC. Final drafts accepted by Canadian Chamber; share with other chambers across country, elicit support, amend as required. Federal Policy Resolution Manual published in English & French.

SEPTEMBER

Attend Canadian Chamber annual Policy Session (Ottawa 2020); present policies to provincial caucus; defendamend; present to floor. Canadian Chamber presents to govt ministries and opposition critics as applicable.

OCTOBER

Distribute annual Member Satisfaction Survey; include prioritization of policy topics and open-ended question asking for policy topics of interest and feedback on process.
